## **SUMMARY**

The WRMP Data-Sharing Policy (Policy) is a document designed to articulate the principles informing the exchange of data and information among partners of the WRMP and the public the program serves. This Policy re-affirms key values, approaches, and practices, while also sharing the practical constraints to be born in mind when sharing data as openly and freely as possible.

The Policy offers essential direction for data sharing, in alignment with the WRMP Program Plan. It also describes the responsibilities associated with the program staff, program partners / contributors, and the general public who must agree to the terms in the Policy prior to using the data.

## Data-Sharing Policy

As a science program that serves and is accountable to the public at large, the San Francisco Estuary Wetlands Regional Monitoring Program (WRMP) aims to uphold high standards for **data transparency**, **openness**, **quality**, and **documentation**. Such standards epitomize the program, from its origin until the present moment. Readily available monitoring data being key to the program's success, the following Data-Sharing Policy (Policy) takes as its purpose the description of how such open-data concepts are put into regular practice across the range of programmatic data outputs.

#### Key Principles for Data Sharing

This document aims for consistency with prior foundational materials, particularly those regarding data management and the data lifecycle. Rather than altering them, this policy extends the relevance of these published materials while providing more details about their application to current program needs.

Accordingly, the latest version of the WRMP Plan (Plan)<sup>1</sup> describes key aspects of data management associated with the program. The following Data-Sharing Policy begins with the concepts detailed in that Plan, while further elaborating them, particularly with respect to the program's data-sharing objectives, processes, and obligations, now that the program has further matured and

evolved. In particular, the Program Plan's "Chapter 3: Data Management" offers some guiding principles which we've endeavored to follow. Those principles include:

• Collaboration among institutions: The WRMP will work across institutions and organizations to achieve program goals.

Effective **collaboration** is fundamental to a multipartner program such as the WRMP, but nowhere more so than in its data-sharing practices. Ensuring that data can be exchanged securely, under known and predictable terms prior to public release, is a goal that aligns with this principle.

• Legitimacy through transparency: The WRMP will function through a fair, deliberative and transparent process.

Data is an essential output of the WRMP, but **transparency** begins long before the generation of the datasets themselves. The program aims to promote transparency regarding all aspects of decision-making regarding the data lifecycle, from planning to release. Whenever possible, the program will favor open-source software, open-data initiatives, and openness with regard to meetings, forums, and decisions. Data attribution and documentation are instruments of transparency, which will be covered in this document.

Distribution that facilitates **discoverability** also serves the need for transparency. If discoverability is hindered – if the WRMP data are difficult to find, access, contextualize, or categorize – then transparency is diminished.

• Long-term ownership and sustainability: We intend that the WRMP, once established, will be long lasting and sustainable.

When considering data sharing and the instruments used to convey the data, the program aims for **efficient and sustainable** practices that recognize the public trust. As such, the administrative team deliberates carefully about its adopted tools and methods to promote cost-effective

decisions with minimal cost burdens as these are more sustainable over the long-term.

• Adaptive management: The WRMP is rooted in an adaptive management model. As new science emerges, the program can adapt [its methods and technology] through adjustment of management questions.

The partners that serve the WRMP commonly adhere to adaptive management practices, and data management is no exception. As the data lifecycle indicates, with planned revisions to data collection and analysis based on prior efforts and coordinated decision making, the program's data management efforts must evolve over time. Clearly, this leads to general process improvement and potential cost savings, but with respect to data, it will also result in **higher quality**, as measured by feedback from the Technical Advisory Committee and Steering Committee.

These principles are consistent with those circulated among prominent governmental agencies, including the <u>National Institutes of Health</u>, <u>US National Science Foundation</u>, and <u>US Environmental Protection Agency</u>, and the <u>State of California</u>.

#### Programmatic Responsibilities

The WRMP itself – administrative staff and governance structure – bears responsibilities to facilitate and incentivize data sharing in alignment with the above principles. The following responsibilities are incumbent upon program staff and associated resources.

#### Sharing in a timely manner

The WRMP, upon collecting or receiving data, shall process and distribute the data in a timely manner, expediting data to be used in time-bound or urgent decisions. In alignment with the program's mission to promote more cost-effective wetland

monitoring in support of permitting, the program shall recognize the need for distribution of information to hasten public decision making.

## Making data public unless there is a clearly stipulated reason for constraining distribution

Whereas some projects assume by default that monitoring data will be withheld from public view, the WRMP shall assume that program data will be made freely available for public distribution unless indicated otherwise.

Some anticipated reasons for a more limited release might include:

- Data that captures personally private or sensitive information. This is also known as PII or "Personally Identifiable Information." Social science data, which has not been otherwise anonymized, would be more likely to contain such sensitive information.
- Data that indicates the location of endangered or sensitive species. For species protection, this information must be either geographically generalized or completely withheld.
- Data owned by a private company, shared under special licensing constraints, used for a specific scientific purpose. The terms of the license would indicate the contractual limitations on distribution.

The program must be informed of such limitations on open distribution prior to data collection or purchase.

#### Documenting methods for generating data

Commensurate with common quality control procedures, it is important to document the methods and/or methodologies for data collection and analysis. Typically captured in a Quality Assurance Program Plan, these procedures will be associated with the metadata (information about a given dataset) and linked to data distribution.

#### Leveraging common vehicles for data distribution

- WRMP.org website will be redesigned to promote discoverability of key datasets, analyses, and interpretations
- "Raw data" shared via the Geospatial Data Portal: data.wrmp.org
- Wetland location, categorization, condition, and project (restoration, conservation, and mitigation) information shared via EcoAtlas
- Derived analyses shared via tools, including ArcGIS Online, RShiny, and other visualization technologies, as referenced by the WRMP.org website.

All of these tools for distribution are subject to change over time as adaptive management re-evaluates their cost-effectiveness.

#### Partner Responsibilities

WRMP partners range broadly from public agencies to private consultants to non-profit organizations to academic researchers. All such partners will be required to observe a number of responsibilities which are often but not necessarily formalized in their contracts, as applicable. Such responsibilities are shared here for public reference:

#### Composing a Data Management Plan

As is a common practice, partners will be required to submit a data management plan (DMP) prior to the start of data collection. This brief document – typically two-to-three pages – will record:

- The types of samples, software, and other materials to be used or produced in the course of the monitoring project.
- The formatting standards to be used for data and metadata content, along with how the metadata will be adapted to the WRMP standard set of attributes.
- Any exceptions to the programmatic standards for data access and sharing, including details regarding the protection of privacy, confidentiality, and/or intellectual property requirements.

- Guidance or constraints on data interpretation, reuse, redistribution and the production of derivatives.
- Exceptions for data submission, with respect to alternative data repositories or retention policies.

This DMP will be revised over the course of the project to keep pace with any unanticipated changes to the project affecting data collection, analysis, or distribution.

#### Conforming to Metadata requirements

The WRMP's Geospatial Data Catalog is an open-source metadata repository, used commonly in public museums, academic libraries, and other institutions with a public mission. At its foundation is a metadata schema based on <u>Dublin Core</u>, which is interoperable with the OpenGeoMetadata open-source systems, with additional metadata attributes customized by the WRMP. While partners may include their own metadata in any submission, they must also complete the WRMP metadata that includes such program-specific information as:

- WRMP Primary Indicator
- WRMP Secondary Indicator(s)
- Subregion(s)
- Operational Landscape Unit(s)
- Topic(s)
- Availability Status

#### **Documenting methods**

In association with the DMP, the methods used for data collection, analysis, and interpretation must be documented thoroughly. This practice not only inspires confidence in the validity of the outputs, but it also promotes consistent observational methods over time as different practitioners undertake the same efforts.

## Planning for public release of information, unless otherwise prohibited

The WRMP recognizes that partners might withhold research materials prior to the publication of a related journal article or research findings. However, this embargo on data sharing must be regarded as a time-bound, temporary provision, with the bias leaning towards open data sharing with few exceptions granted to those protecting private or sensitive information.

#### Public Responsibilities<sup>2</sup>

The following describe the responsibilities to be observed by the general public, those persons not otherwise included as WRMP staff, partners, or contributors.

#### Observing and sharing attribution

Unless otherwise specified in association with specific information distribution, all information, software, and data distributed via these program resources may be redistributed with proper attribution to the WRMP and with reference to the specific Website page by which the source information is originally posted or shared. You must not reproduce, distribute, modify, create derivative works of, publicly display, publicly perform, republish, download, store, or transmit any of the material on our websites without attribution to the WRMP.

### Honoring data-usage guidelines and other provisions indicated in the metadata

The information presented on or through the program websites is made available for public benefit and without any assurance or warranty of the accuracy, completeness, precision, timeliness, or usefulness of this information.
